Your summons requires you to appear in person before the Municipal Court of Fredericktown, Missouri, on the date and time indicated on the summons. If you wish to plead guilty and pay your fine and court costs, it must be paid no later than the day before your scheduled court date.

**ONLY** those violations listed below may be paid prior to court.

**NOTICE: YOU MUST APPEAR IN COURT IF YOU WERE INVOLVED IN AN ACCIDENT.**

If it is your intention to plead NOT GUILTY to the violation, you must appear in court on the date and time indicated on your summons.

**WARNING:** A warrant will be issued for your arrest if you fail to appear in court or pay your fine by the scheduled appearance date.”
